2017/16 County Borough Council

- a. Flooding in Llanspyddid – Cllr. Hill has had a meeting with the contractors. The report will be out on 17th March 2017. The culverts is constantly blocking with leaves.
- b. Speeding issues in Libanus, Llanspyddid and Llanhamlach – nothing to report
- c. A dog mess bin is needed outside Libanus playground – Cllr. Fitzpatrick has requested this
- d. A refuse bin is needed at the bus stops in Libanus – Cllr. Fitzpatrick has requested this.
